

Biggest Little Furry Convention - Parental Permission & Release form

Biggest Little Furry Convention (BLFC) is an annual convention celebrating the artistic expressions of fans of anthropomorphic artwork. No special concessions are being made for the attendance of minors, but they are allowed to attend. Please carefully read the rules below.

- If your child is **under 16** (born after October 21, 2005), **you will need to supervise them at all times.**
 - **Convention staff cannot and will not supervise your child, and will not act as a temporary parent for your child.** You and your child will be ejected from the convention if your child is left unsupervised.
- If your child is **between 16 and 18** (born after October 21, 2003), your child may be left unsupervised.
 - **This form must be notarized if you will not be present.**
- You are responsible for ensuring your child obeys convention policies (<https://goblfc.org/policies>), whether or not you are present. Policy violations by either you or your child will result in revocation of both your memberships.
- BLFC is an unsupervised environment intended for mature adults, and is not responsible for the conduct of attendees. Parent agrees to indemnify and hold harmless both BLFC and the Grand Sierra Resort, and both companies' officers, directors, agents, volunteers, and employees with respect to all activities associated with, or any damages arising out of BLFC and from any cause of action of any nature arising from their child's participation in BLFC. **Be aware this convention is intended for adults, and your child may be exposed to "PG-13" behavior while in convention space.**

Biggest Little Fur Con 2021 - Attendee Release and Authorization

COVID-19 has been declared a worldwide pandemic by the World Health Organization and is extremely contagious and believed to spread mainly by personal contact with individuals without symptoms. Reno Area Anthropomorphic Arts and Recreation (“RAAAR”) has implemented new procedures and standards in order to comply with CDC requirements and other safety precautions in order to keep you as safe as possible during your attendance at RAAAR’s event, Biggest Little Fur Con (“BLFC”). This includes numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19; however, RAAAR cannot guarantee that you will not become infected with or further spread COVID-19 by attending BLFC. Further, attending BLFC may increase the likelihood that you may become infected with COVID-19.

Your risk includes exposure to or becoming infected by COVID-19 which may result from the actions, omissions, or negligence of others, including, but not limited to RAAAR’s employees, volunteers, and other attendees. **YOU CONSENT TO KNOWING THE DANGER INVOLVED, AND HEREBY AGREE TO ACCEPT ANY AND ALL RISKS OF DAMAGE, INJURY, SPREAD OF COVID-19 OR DEATH, AND VERIFY THIS STATEMENT BY PLACING YOUR INITIALS HERE: _____**

RAAAR requires that all volunteers and employees wear masks while working BLFC. Additionally, RAAAR requires that attendees submit proof of vaccine or receive a negative COVID-19 test within 72 hours prior to attending BLFC. If RAAAR suspects that any volunteer or employee may be infected with COVID-19, they will be sent home immediately and will be asked not to return to BLFC for the remainder of the event.

You hereby agree, on your behalf that you, and your respective assignees, heirs, guardians, and legal representatives will not make any claim against, sue, or attach the property of RAAAR for any illness, injury or death resulting from the negligence or other acts, howsoever caused, by any volunteer, employee, agent, or contractor of RAAAR as a result of your visit to BLFC. You hereby release and discharge RAAAR from all actions, claims, or demands that you and our respective assignees, heirs, distributees, guardians, and legal representatives now have or may hereafter have for injury, illness or death resulting from your visit to BLFC.

You hereby agree, on your behalf, and your respective assignees, heirs, distributees, guardians, and legal representatives expressly waive, release, discharge, indemnify, save and hold harmless RAAAR, its respective officers, directors, successors, assigns, employees, agents, successor and assigns (collectively referred to as “Releasees”) from and against any and all liability or claims arising from injury or claims of damage to person caused by or resulting from your visit to BLFC.
